

She has lectured at colleges, spoken at many conferences and been a guest on many news programs like Larry King and Anderson Cooper 360. She has many professional and civic awards for her contributions to the legal field and her community.

"When you see all Diane has accomplished, you can see Gov. Newsom made the right choice," Ms. Wanger said.

For her part, Ms. Goodman said she looks forward to serving the public as a judge.
